AFFIDAVIT OF CAROL LONG



1. My name is Carol Long and I have personal knowledge of the facts stated in this affidavit.

I am Deputy County Administrator for the Morgan County Commission and, as such, have in my custody and control the records of the Morgan County Commission maintained in the ordinary course of its business. From time to time, the Morgan County Commission makes payments to other governmental entities who house Morgan County Jail inmates at the request of Morgan County and the Morgan County Sheriff. Records of such

payments are made in the ordinary course of Morgan County's business by recording and entering such payments to a computer accounting system in the regular course of business and as such payments are made.

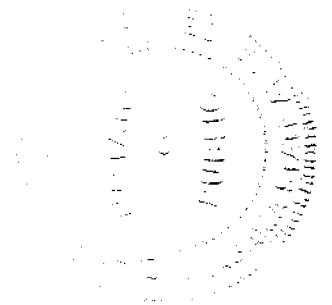


